ANNUAL REPORT: Calendar Years 2010 and 2011 OF THE BALTIMORE CITY BOARD OF ETHICS

INTRODUCTION

The following report provides the Mayor, Department of Legislative Reference, Board of Estimates, City Council, all employees of Baltimore City and the general public with information regarding the activities of the Baltimore City Board of Ethics ("Ethics Board") for calendar years 2010 and 2011.

This report is made pursuant to the Baltimore City Charter which provides that "every municipal agency of the City shall prepare annually a written report of its work and proceedings." See Baltimore City Charter, Article I, Section 5(c). Boards and commissions are included in the City Charter's definition of municipal agency, making this report mandatory. See Baltimore City Charter, Article I, Section 2(j). Additionally Article 8, §3-26 (1) requires the Ethics Board to submit an annual report on its activities.

In existence for almost forty-nine years, this is the second "Annual Report" prepared by the Ethics Board. General information regarding the history, purpose, goals, procedures, staffing and members of the Board is provided.

The Ethics Board and its administrators are pleased to submit this report about the work that they have been asked to undertake. The Board looks forward to addressing any questions or suggestions that might arise following review.

HISTORY OF THE BOARD OF ETHICS

The Baltimore City Board of Ethics was established in 1963 by an amendment to the Baltimore City Charter. The purpose was to enforce certain new prohibitions against conflicts of interest. Financial disclosure requirements were added in 1974.

In 1981 the State of Maryland enacted the comprehensive "Maryland Public Ethics Law" which, among other things, mandated that each local jurisdiction adopt its own local ethics laws. The local laws were required to be "similar" or "substantially similar" to the Maryland ethics law. Accordingly, the Baltimore City Charter and the Baltimore City Code were revised and expanded to comply with the State law.

In 2004 the Baltimore City ethics law was revised again. This time the law was substantially expanded and clarified by Ordinance 04-795 (known as "Ethics – Raising the Bar") that became effective in 2005.

In 2010 there were two major revisions to the Law. Ordinance 10-267 clarified terms applicable to certain prohibited acts, required disclosures and other ethics regulation; it further clarified and expanded the scope of those to whom certain prohibitions apply; and it generally related to ethics in the public sector. Ordinance 10-272 reconstituted the five member Board to include a member nominated by the President of the City Council, a member nominated by the City Comptroller and three members named by the Mayor, two of whom must be members of the Maryland Bar. Additionally, the amendment clarified the qualifications of the Board members and established staggered five-year terms of office. The Board was also authorized to elect a Chair and other officers from among its members. The Ordinance further expanded the list of officials required to attend training and added the requirement for the Board to submit an Annual Report of its activities, and as appropriate, special reports with recommendations for legislation.

In 2011, the Maryland General Assembly amended the State Ethics Law to require that all local jurisdictions enact laws that are substantially similar to the State Ethics Law, Chapter 277. Therefore legislation, Ordinances 11-484, 11-520 and 11-573, were introduced to bring Article 8 into compliance with the state law. The major changes included revised definitions of insignificant and significant gifts, prohibited employment interests, specifically prohibited gifts, and restriction on elected officials after departure from office, , a requirement of disclosure of employment and interests that might raise a potential conflict of interest in connection with a specific proposed action by an official, and the addition to the disclosure requirements of the Baltimore City Health Department, Police Department and the Civilian Review Board.

PURPOSE, GOALS AND DUTIES OF THE BOARD OF ETHICS

The Baltimore City Ethics Law is intended to "guard against improper influence or even the appearance of improper influence and to ensure public trust in the government". The Ethics Law accomplishes this goal by:

- Setting ethical standards on the conduct of all Baltimore City officials and employees so as to prevent a conflict of interest or the appearance of one;
- Requiring Baltimore City officials and high-level employees, within 6 months of appointment, to undertake formal training in the requisites of the Ethics Law and to sign and to submit a certified "Conflicts Affidavit";
- Requiring Baltimore City officials, specified employees and specified members of Baltimore City boards and commissions to file annual financial disclosure statements that are certified and open to the public; and
- Requiring legislative and executive branch lobbyists to file registration statements and periodic activity reports, open to public inspection.

The Ethics Board also:

- Issues advisory opinions on questions regarding the Ethics Law;
- Grants exemptions from certain provisions of the Ethics Law under appropriate circumstances;
- Investigates alleged violations of the Ethics Law; and

• Enforces compliance with the Ethics Law.

The Ethics Board does not:

- Prosecute criminal conduct. However, criminal conduct discovered by the Ethics Board during its investigation of a complaint is referred to the appropriate prosecuting authority for handling.
- Administer personnel matters or seek to resolve personnel conflicts.

MEMBERS OF THE BOARD OF ETHICS

The Baltimore City Board of Ethics currently consists of five unsalaried, non-compensated members. Members must be "of known personal integrity" and must possess "recognized knowledge and interest in government and civics."

The following appointees, under the revisions in Ordinance 10-272, were confirmed in June 2010. The Board selected Linda B. "Lu" Pierson as Chair and Dawna M. Cobb as Recording Secretary.

MEETINGS OF THE ETHICS BOARD

The newly appointed Ethics Board met in person monthly. Except for the Board's initial training meeting in July 2010, all meetings were held in the Offices of Legislative Reference on the 6th floor of City Hall. As required, advance notice of meetings and the possibility of closed sessions were given to the public and media. All decisions of the Board are reflected in the Minutes of the monthly meetings and are available on the Ethics Board Website.

Generally, agenda topics included receipt of updates of ongoing investigations, consideration of exemptions from solicitation rules, both informal and formal requests for opinions on the application of Ethics laws and regulations, and consideration of legislation affecting the administration and scope of the Ethics Law.

ETHICS BOARD ADMINISTRATION

The Baltimore City Ethics Code provides that the Director of the Baltimore City Department of Legislative Reference shall also serve as the Executive Director of the Ethics Board. Avery Aisenstark, Esq. serves this dual role.

With the assistance of the City's Information Technology Department, the Department of Legislative Reference staff also maintains the Ethics Board Website and updates the site as needed and appropriate. The new Board expanded the information available to include the Minutes of Meetings and copies of Opinions.

Additional support is provided by Thaddeus Watulak, Esq. Deputy Ethics Director, and Anita Evans, Registrar, both seconded from the Department of Legislative Reference. From time to time the Board receives assistance from the Office of the City Solicitor and the Inspector General's Office. Mr. Aisenstark, Mr. Watulak, and Ms. Evans can be reached at 410-396-4730.

GOVERNMENTAL/CHARITABLE SOLICITIONS

Article 8, § 6-26, "Gifts: Solicitation prohibited," generally prohibits any public servant from soliciting or facilitating the solicitation of a gift, "whether on the public servant's own behalf or on behalf of another person," from any person that the public servant "knows or has reason to know" is a controlled donor. Article 8, § 6-27, "Gifts: Acceptance prohibited," further prohibits any public servant from accepting a gift, even if unsolicited, from any person that the public servant "knows or has reason to know" is a controlled donor.

These prohibitions have long been recognized to apply even if the "gift" is being solicited to support a governmental function or charitable endeavor. An exception was enacted in 2005 to permit certain solicitations that are "for the benefit of an official governmental program or

activity of a City-endorsed charitable function or activity" and have been pre-approved by the Ethics Board and endorsed by the Board of Estimates or its designee.

The regulations were adopted in January 2010 and became effective on March 1, 2010. In brief, the regulations require prior approval before charitable solicitations are begun, confirmation that the proposed solicitation is for a *bona fide* public purpose, identification of the types of persons and/or businesses that will be solicited, periodic reporting regarding the progress of the solicitation and final reporting on the outcome of the solicitation. The regulations are available for review at the Ethics Board website.

According to the Ethics Code, Solicitation Requests must receive approval by the Board of Estimates prior to submitting the request to the Ethics Board. On November 8, 2010, the Board met with Renee Samuels, Special Assistant to the Mayor, to discuss the solicitation activities of the various Sister City programs and the need to get appropriate prior approval of the Board of Estimates and the Ethics Board before beginning solicitations.

Since the current Board started service in June 2010, the Board received and approved eight (8) applications for Approval for Governmental/Charitable Solicitations during 2010 and twenty-three (23) applications in 2011.

EDUCATION AND TRAINING COURSES

Pursuant to Ethics Law Section 3-20 the Ethics Board must develop and offer a training course of not less than two hours on the requirements of the Baltimore City ethics laws. Every official must complete the training course within six months of appointment or reappointment to office. The requirement does not apply to an official who, within the three years preceding their appointment or reappointment, completed a training course provided under Section 3-20.

In addition, an individual who is appointed to fill a vacancy in a position must be given written notice of the requirements related to the filing of a financial disclosure statement, taking a training course and submission of a conflicts affidavit. The Mayor or the Mayor's designee must give notice to uncompensated appointees of the Mayor. For all other appointees, the notice must be given by the Director of Human Resources or the Director's designee.

On an annual basis, the Ethics Board must notify agency heads of the availability of the ethics training course. In October 2010 and again in December 2010 a Questionnaire was sent to every City employee explaining who is required to complete the training and file a Conflicts Affidavit. The questionnaire also provided dates of available training sessions.

During Calendar **Year 2010**: 19 Training Sessions were held. More than 508 individuals completed the Training. At least 76 hours of staff time were expended to provide this training.

Calendar **Year 2011:** 22 Training Sessions were held.

More than 600 individuals completed the Training. At least 88 hours of staff time were expended to provide this training.

Ordinance 10-272 –[" Ethics Board Composition, Tenure, etc. – Ethics Training"] expanded the requirements for mandatory ethics training to newly encompass various boards, commissions, and other multi-member entities. The Ethics Board continues to seek comprehensive information on the affected boards, commissions, etc. from the City Department of Human Resources and the Mayor's Office.

LOBBYING

Lobbying activities are governed by Subtitle 8 of the Ethics Laws and fall into the following categories:

Legislative Lobbying - A person must register as a lobbyist if, during a reporting period, the person, for the purpose of influencing any legislative action, communicates with a public servant and, spends \$100 or more for gifts, including meals, beverages or special events, incurs any expenses of \$500 or more or, earns \$2,500 or more in compensation.

Executive Lobbying – In general, a person must register as a lobbyist if, during a reporting period the person, for the purpose of influencing any executive action, communicates with a public servant and in connection with that communication spends \$100 or more for gifts, including meals, beverages or special events.

Lobbying Related to Executive Orders – With respect to influencing the development, adoption, issuance or amendment of regulations or of an executive order, a person must register if during a reporting period the person communicates with a public servant regarding the executive order and in furtherance of that communication spends \$100 or more for gifts, including meals, beverages or special events, incurs any expenses of \$500 or more or, earns \$2,500 or more in compensation.

Lobbying Related to Procurement Matters – A person must register as a lobbyist if, during a reporting period the person, for the purpose of influencing executive action on a procurement contract that exceeds \$50,000, communicates with a public servant and spends \$100 or more for gifts, including meals, beverages or special events or, is compensated for his or her services. Bona fide salespersons are excepted so long as they engage in no other act during the reporting period that requires registration.

Lobbying Related to Business Grants or Loans – A person must register as a lobbyist if, during a reporting period the person, for the purpose of influencing executive action to secure for a business entity a grant or loan that exceeds \$50,000, communicates with a public servant and spends \$100 or more for gifts, including meals, beverages or special events to one or more public servants or, is compensated for his or her services. A *bona fide* full-time official or employee of a business entity that is seeking to secure a grant or

loan, or a person seeking a grant or loan for the purpose of locating, relocating or expanding a business in or into the City of Baltimore is excepted.

Grass Roots Lobbying – A person must register as a lobbyist if, during a reporting period the person, for the purpose of influencing any legislative or executive action solicits others to communicate with a public servant and spends \$1,000 or more, including expenditures for salaries, contractual employees, postage, telecommunications services, electronic services, advertising, printing, or delivery services.

The Ethics Law requires that a lobbyist register within 5 days after first engaging in any act that requires registration. Registration forms are due on or before January 1 of each year if, on that date the lobbyist is engaged in lobbying. A separate registration form must be filed for each person or entity for which the lobbyist is lobbying.

Lobbyists are also required to file activity reports on an annual basis. Activity reports must include information regarding the total compensation paid to the lobbyist in connection with lobbying activities, office expenses incurred, gift expenses, and expenses related to publications, witnesses and research. Activity reports must also include the name of each public servant and/or qualifying relative of a public servant to or for whom the lobbyist or any person on their behalf has given one or more gifts with a cumulative value of \$150 or more, whether or not given in connection with lobbying activities.

A list of lobbyists registered with the Ethics Board in 2010 and 2011, and their clients, can be found as Appendices 2 and 3. The current list is available from Anita Evans, Registrar, Department of Legislative Reference.

FINANCIAL DISCLOSURE STATEMENTS

The Ethics Board is charged with the responsibility of processing financial disclosure forms from elected officials, agency heads, select employees, candidates for office and members of Baltimore City boards and commissions. The categories of persons who are required to file financial disclosure forms are found at Sections 7-6 to 7-14 of the Ethics Law. The Board estimates that over 2,000 people file these forms each year.

Financial disclosure forms are due on or before April 30 of each year, must cover the calendar year immediately preceding the filing and must be notarized. A fine is authorized for late filings, up to a maximum of \$250 per late filing.

In a 2011 preliminary audit by the Baltimore City Department of Audits the methodology and processes for assuring that the required employees and officials file Financial Disclosure Forms was found to be inadequate. The Board directed the staff to request assistance from the Department of Human Resources in resolving the process of identifying those individuals required to file Disclosure Forms, including both current and recently terminated employees.

In September 2011, the Board approved a change on the Financial Disclosure Forms. Previously, the filer was asked for "home address." The Board felt that the term, "principal residence," should be consistent with the term used in the state tax credit law. Thus, the new definition to be used on the Financial Disclosure Forms will read: "Principal residence means a dwelling that is used as a person's principal or primary home and that is actually occupied by that person for more than six months of a twelve month period."

All financial disclosure statements are available for public inspection at the office of the Department of Legislative Reference. Contact Anita Evans, Department of Legislative Reference, City Hall, 100 N. Holliday Street, Baltimore, Maryland 21202. 410-396-4730.

Under Section 7-1(d) the Finance Director must annually certify to the Ethics Board a list of all business entities doing business with the city. The Ethics Board must keep this list on file and available to all persons subject to the Financial Disclosure requirements. The Board has been receiving multiple lists which cannot be easily searched. The Ethics Board will continue to request a more easily referenced list of business entities from the Finance Department.

LEGISLATIVE MATTERS

The Ethics Board becomes involved in legislative matters primarily when proposed legislation is referred to it for review and comment. The Board also has the authority to propose legislation that amends or regulates the Ethics Law. In 2010 and 2011 the Ethics Board engaged in both activities.

ETHICS INQUIRIES

The Ethics Board received numerous documented inquiries in 2010 and 2011. Inquiries come from elected and appointed officials, members of Baltimore's boards and commissions, Baltimore City employees, members of the public, members of the media, local agencies, and private business entities. In addition to documented inquiries, the Ethics Board staff Executive Director and Deputy Ethics Director frequently handle simple ethics questions and requests for information. These kinds of inquiries are not generally documented and they are not summarized in this report.

Section 4-1(a) of the Ethics Law provides that "at the written request of a person who is subject to this article, the Ethics Board must provide an advisory opinion, in a timely fashion, on the article's application to that person under the circumstances described in the request." Inquiries submitted on behalf of persons who are not subject to the ethics laws *may* be responded to with an advisory opinion. In 2010 and 2011, every written request for an advisory opinion was considered by the entire Ethics Board, excepting those members who recused themselves due to a real or perceived conflict of interest.

Often, the Board's Executive Director, Avery Aisenstark or Deputy Ethics Director, Thaddeus Watulak, responded in person, by telephone or e-mail to questions with clear or easily ascertainable answers and with no Board involvement.

ADVISORY OPINIONS AND WRITTEN DECISIONS ISSUED

All written advisory opinions, with the name of the inquirer redacted, are made available to the public. In 2011 three formal Opinions were issued. The full text of each opinion is available on the Ethics Board Website or through the Department of Legislative Reference. Contact Anita Evans, Department of Legislative Reference, City Hall, 100 N. Besides the three formal opinions issued in 2011, the Ethics Board received nine other written requests for opinion in 2010 and 2011. Each inquiry generated a written response. A summary of each inquiry and the Board's response can be found in Appendix 4.

COMPLAINTS

The Baltimore City Ethics Law specifies the process and procedure for making and responding to complaints of a violation of the law. These are found at Subtitle 5.

Any person may file a complaint with the Ethics Board alleging a violation of the ethics laws. Complaints must be in writing, under oath and signed by the complainant. The Ethics Board itself can issue a written complaint alleging a violation of the ethics laws. Once a complaint is received, the Board's Executive Director must promptly send a copy of the complaint to the respondent. In the case of a complaint made by a person or entity other than the Ethics Board, the complainant's name and any other information identifying the complainant must be redacted in public copies.

The Executive Director is required to promptly investigate a complaint. Findings are then reported to the Ethics Board. If the Ethics Board determines that the facts do not merit further proceedings the Board must dismiss the complaint and notify the complainant and respondent of this determination.

If the investigation discloses a prima facie violation the Executive Director must notify the respondent of this and provide the respondent with an opportunity to cure the violation. If, within 15 days, the respondent cures the violation and the Ethics Board finds that a dismissal would not be contrary to the purposes of the Ethics Code the complaint may be dismissed. The respondent and the complainant are then notified of the decision to dismiss the complaint.

If a complaint is not dismissed the Ethics Board must provide the respondent with notice and an opportunity for a hearing before the Board. The respondent is entitled to be represented by counsel. After all of the evidence has been presented the Ethics Board must make written findings of fact and conclusions of law as to each alleged violation.

Alternatively, if the Ethics Board determines that the respondent has not violated the ethics laws the Board must dismiss the complaint and promptly notify the complainant and the respondent of the dismissal.

If the Ethics Board determines that the respondent has violated any provision of the Ethics Laws the Board may take one or more of the following authorized enforcement actions. Actions include:

- Issuing an order directing the respondent to cease and desist from the violation;
- Issuing a reprimand;
- Referring the matter to the appropriate official or authority for other disciplinary action authorized by law, including censure or removal;
- Seeking judicial relief or other enforcement action;
- Requiring a respondent who is a lobbyist to file any additional reports or information;
- Imposing a \$1,000 civil penalty for each violation related to a respondent who is a lobbyist; and
- Referring the matter to the appropriate prosecuting authority if there are reasonable grounds to believe that the respondent has committed a criminal offense.

Respondents can seek judicial review of a decision of the Ethics Board by petitioning the Circuit Court for Baltimore City. A party to that judicial review has the right to appeal the Circuit Court's final judgment. Appeal is to the Court of Special Appeals in accordance with the Maryland Rules of Procedure.

Once a complaint is made, the proceedings, meetings and activities of the Ethics Board and its staff relating to the complaint are confidential. Neither the Ethics Board nor its staff may disclose any information relating to the complaint including the identity of the complainant or the respondent. However, if a violation is found, the identification of the respondent can be revealed.

The Commission received fifteen (15) complaints of possible ethics violation in 2010 and 2011. Appendix 5 provides a summary of the complaints. One complaint was extensively investigated and charges were filed on three areas of the Code. Preparations were being made for a formal Hearing when the complainant proposed and accepted a settlement of the matter.

APPENDIX 4

Opinion Requests

Members of a Commission inquired to the applicability of post-employment restrictions. In August 2010, the Board voted to defer this issue pending more information from that Commission.

September 2010 – Request from the Mayor's Office for an Opinion on the receipt of "In-kind" services from individuals and corporate entities. – The Board requested more information since the request was too broad. The Board, further, reiterated the rule on gifts.

November 2010 – Request from a member of City Council for an opinion regarding pending legislation was withdrawn as moot since the legislation was withdrawn

January 2011 – Request from an official regarding an employee's purchase of a Tax Sale Certificate. It was determined that the employee participated in an activity that was generally available to others and that the official was exercising normal ministerial duty in completing the sale.

February 2011 – Request concerning a member of City Council regarding proposed legislation that would allow council members to represent constituents at the Environmental Control Board. Because non-lawyers are not allowed to represent parties before the ECB to do so would constitute the unauthorized practice of law; additionally, this participation would violate the prestige of office principle.

February 2011 – Request from an elected official regarding his/her involvement in bringing a Washington Capital Hockey Game to Baltimore. The Board advised the official that his/her current involvement in bringing the pre-season game to Baltimore did not raise a prestige of office issue since it was permissible constituent service. If, however, there are future activities around this arrangement, e.g.; donation of tickets, the Board should be informed.

March 2011 – Request from the Fire Department concerning their participation in an advertising campaign for specialized flashlights in exchange for some firefighting equipment. The Board agreed that the BCFD insignia cannot be used in the photo short and that the terms of the arrangement comprise a bargained for exchange of equal value rather than a gift.

March 2011 – Request from the Department of Transportation regarding a demonstration project to display bike racks made by different vendors at a City owned garage. The Board agreed to the project provided DOT rotates the bike racks thereby giving the involved vendors equal opportunity to display their racks.

April 2011 – Request from the Law Department regarding legal advice provided the Mayor regarding her husband's employment as a potential conflict.

Opinion 11-001, issued May 10, 2011 – Regarding Sponsorship solicitation campaigns for certain City events or activities. The Board determined that a campaign to solicit sponsorships of City facilities, activities, or events does not need to be approved by the Ethics Board if the campaign:

- 1. Publically offers the opportunity to become a sponsor to a broad group of potential sponsors;
- 2. Describes any criteria that will be used to select the sponsors or to determine whether certain entities are ineligible to be sponsors; and
- 3. Is approved by the Board of Estimates.

May 2011 – Request from a member of City Council regarding family employment. The Board issued **Opinion 11-002, August 11, 2011:**

Regarding whether an Official is required to recuse from certain matters because of the employment status of family members. This opinion clarified the definition of an "entity doing business with the city" and distinguished between a separate legal subsidiary of a university and the system as a whole.

September 2011 – Request from an elected official regarding recusals. The Board's decision became **Opinion 11-003, issued 11-14-2011** which states the standards governing recusals based on family members' employment and officials who have multiple roles in city government.

APPENDIX 5

Complaints

Aug. 2010 – Complaint received regarding a public officials endorsement of a candidate for Baltimore City State's Attorney – Complaint withdrawn 8-20-2010

Aug. 2010 – Inquiry received regarding an incomplete disclosure form filed by a City employee. The Disclosure Statement was amended and clarified in August 2010.

August 2010 – Complaint filed by an individual. Dismissed because the complaint did not allege any violation of the Ethics Code.

August 2010 – Complaint filed by an individual with the Inspector General. Upon the request of the IG, the Board authorized the IG to pursue an investigation of the complaint alleging violations of Art. 8.

September 2010 – Complaint filed alleging political use of City of Baltimore e-mail was immediately cured by the employee who apologized to the complainant for the inadvertent forwarding of an improper e-mail.

September 2010 – Complaint alleging a potential violation of City Code Article 8, § 6-36 – Prestige of office. The investigation of the situation did not disclose any intentional interventions on behalf of an organization. The involvement was viewed by the City Agency as regular constituent services and did not influence the ultimate outcome of the individual's complaint to the City Agency. Therefore, the Board determined that there was no violation of City Code Article 8, § 6-36 and dismissed the complaint

December 2010 – The Board requested the Inspector General's Office to investigate whether members of the Board of the Baltimore's Employee Retirement System have complied with the Ethics rules related to travel to attend conferences sponsored by certain vendors.

May 2011 – Anonymous complaint from Naked Truth regarding the hiring of an "unqualified" person in the Dept of Transportation. IG was requested to investigate.

June 2011 – Complaint by an individual concerning the improper hiring in the Office of Human Resources. The complaint was determined to be unfounded and was dismissed August 2011.

July 2011 – Anonymous Complaint regarding fraud and embezzlement by an individual in the Mayor's Office of Employment Development. The complaint was referred to the IG for investigation.

July 2011 – Complaint against an elected official misconduct. The complaint was determined to be unfounded and it was dismissed 9-2011.

August 2011 – Complaint against a member of two boards regarding his participation in siting on both the Commission on Historical Preservation and Architectural Preservation (CHAP) and the Board of the Maryland Historical Trust.

August 2011 – Complaint against an elected official regarding conflict of interest in matters involving the official's spouse. Complaint dismissed since the facts did not support a conflict of interest 9-2011
